

## KING GEORGE V PLAYING FIELDS

**Cllr. Dilip Patel** and **Cllr. Jason Frost** recently met with residents of Linley Crescent to discuss several concerns relating to the meadow area of King George V Playing Fields. First and foremost was the issue of security at this location. Residents have complained for some time about the

use of the top corner of the meadow for anti-social purposes. The area borders the river and is largely concealed from the path. Residents would like to see the installation of more robust fencing at this location in order to prevent the site being used for criminal activity.

Secondly, was the issue of the size and volume of tree growth around the edge of the site. Those residents bordering the park have sought the Mawneys Team's support in having Parks reduce the size of several of the now very large mature trees which grow along the boundary fence due to significant overhanging and damage to garden property.

Site meetings have now taken place with officers from the Parks Dept and actions are being taken to address these issues.

#### PARKING BAYS

After an intensive period of lobbying, the Mawneys Team are pleased to see that the parking capacity review in Lynton Avenue and Rodney Way has now finally been completed, and the foot way parking bays re-lined



accordingly. **Jason, Dilip** and **Carol** would like to extend our sincere thanks to the Highways Team for their support in getting this programme finished.

#### FAIRCROSS AVENUE

Following a recent visit to the small patch of waste ground close to the junction with Chase Cross Road, **Cllr. Dilip Patel** noted that this area is now once again badly overgrown and obstructing the footway. Civil Enforcement have been asked to notify the owner of the need for action at this site.

## PLAGUE OF SHOPPING TROLRIES

It has come to our attention that shopping trolleys are regularly being taken off the premises of local supermarkets and then casually discarded at locations across the area. Whilst this activity may seem relatively harmless, the act of removing a branded shopping trolley off the premises of a supermarket actually qualifies as theft. The further discarding of the trolleys on the public highway constitutes an act of fly-tipping, which is an enforceable offence. We ask all residents to refrain from engaging in such activity. Please notify us right away if you spot it happening.



## NORTH STREET UNDERPASS CLEAN UP

The North Street underpass has again been the target of a senseless graffiti attack. Thankfully, the scrawled words were neither offensive nor politically motivated (as has been the case in the past). Transport for London (TfL), who are responsible for the maintenance of this underpass, have now been informed and action will be taken to clean up the location in due course.



## DUMPED RUBBISH!

In the past few months there have been several incidents of dumping of large amounts of rubbish in Hereford Gardens (behind the White Hart Lane shopping parade). This illegal activity has been traced to a specific nearby address. The Council's Enforcement Team is now investigating.
